Apprentice and Novice riders must sign a Rider Accreditation form. Failure may result in a fine, scratch or both. Forms can be emailed to Don Yovanovich at dony13@aol.co or presented to Pippy McCormick at the races.

**If you have not received a pass, owners, trainers, riders, officials, grooms, sponsors and photographers will be on a list at the entrance. When you arrive, you will sign a Covid 19 Waiver Form and a Health Questionnaire. You will also have your temperature taken.**

All riders must sign Waiver of Liability forms and must provide proof of insurance before being allowed to ride.

All people who plan to be on horseback must sign Waiver of Liability forms and must wear protective headgear and vests.

All horses must be checked in with Pippy McCormick at the paddock one hour prior to their post time listed on this overnight, or they will be scratched.

NO toe grabs, caulks, stickers, turndowns, inserts, trailers or heel extensions will be allowed on the front or hind shoes. Note: The insert on the toe of the Queen's Plate is considered a "wear plate," not a toe grab. Block heels on the hind shoes (not to exceed ¼ inch) are permissible. Outer rim shoes are prohibited. ONLY QUEEN'S PLATE FLAT, QUEEN'S PLATE WEDGE AND STEEL TRAINING PLATES OR THEIR EQUIVALENT MAY BE USED.

Please check the information on this overnight. Any changes or corrections can be made prior to scratch time to make the program.

Entries must be paid before saddle cloths will be issued.

As required by the Virginia Department of Agriculture: "All horses must be accompanied by a report of an official negative test for equine infectious anemia (Coggins Test) conducted within the last 12 months. The Certificate must accompany all horses in order to gain access to the grounds. This requirement will be strictly enforced. A health certificate must accompany horses shipping from outside Virginia.
