\* Trainers can declare their horses with Pippy McCormick prior to arrival using mobile number 540-455-3854. Race day scratches can also be made with Pippy McCormick.

\* NOTE Rule 1. Horsemen are liable for all entry fees that are made for each point to point or pair event. A scratch does not void an entry fee. (PLEASE NOTE Rappahannock Hunt generously waives all STARTER entry fees for their race day. Scratches still owe)

\* Please review Rule 25 on page 2 of the condition book regarding the mandatory shoe rule.

\* All novice riders need a certification form, contact Don Yovanovich for assistance. Rule 37 page 2.

\* Riders in the Foxhunter Series must wear foxhunting attire and present a proper certification from a master of your days hunting - To be turned into Pippy McCormick.

\* All Riders must sign Waiver of Liability forms and must provide proof of insurance before being allowed to ride.

\* All people who plan to be on horseback must wear protective headgear. All race riders must wear protective vests.

\* Entries must be paid before saddle cloths will be issued.

\* As required by the Virginia Department of Agriculture: "All horses must be accompanied by a report of an official negative test for equine infectious anemia (Coggins Test) conducted within the last 12 months. The Certificate must accompany all horses in order to gain access to the grounds. This requirement will be strictly enforced. A health certificate must accompany horses shipping from outside Virginia.

\*\*\*PLEASE NOTE - Email us your Coggins (alissa@centralentryoffice.com) and we'll create a list for the race meet to make reporting easier for them. Please ALSO be sure you have your Coggins WITH YOU WHEN YOU CHECK IN.
